Introduction

- The NHS Assembly is a new forum that will bring together a range of individuals from across the health and care sectors at regular intervals to advise the Boards of NHS England and NHS Improvement on delivery of the NHS Long Term Plan.
- 2. The Assembly membership will bring broad stakeholder insight and frontline experience to discussions, serving as a "guiding coalition" on implementation of the improvements outlined in the plan.

Context

- 3. As discussed by the Board in February, an open, competitive appointment process resulted in the appointment of Professor Sir Chris Ham and Dr Clare Gerada as Co-Chairs of the NHS Assembly.
- 4. An invitation for expressions of interest in becoming a member of the NHS Assembly closed in March. Over 500 applications were received and we are grateful to all those that took the time to do so.

Current position

- 5. We have now completed the process of reviewing all expressions of interest and can confirm the membership (attached at annex A).
- 6. Members have been selected based on their individual knowledge, skills and experience, not to represent a specific organisation. To ensure a variety of

experience, the shortlisting process specifically considered appointing a balanced and diverse membership drawing from across different stakeholder groups including:

- Frontline clinicians
- Staff
- Patient, Carer and Public voice networks
- Voluntary, Community and Social Enterprise sector
- National clinical leaders
- Health and Care sector system leaders
- Think Tanks and health research sector.

Next steps

- 7. The first full meeting of the Assembly will be held in central London in late April. The assembly is expected to meet quarterly thereafter.
- 8. The Assembly will have an agreed programme of work informed by wider engagement, including with existing fora and networks promoting the voices and views of patients, staff, clinicians and others, which will bring greater insight to support Assembly discussions.
